**Job Duties:**

Acts as agency lead for statewide interagency collaboration on homelessness & affordable housing issues: Serves as Office of Community Development (i.e., OCD) lead for the Housing & Homelessness Collaborative (i.e., HHC) & on any applicable workgroups; acts as primary staff to coordinate OCD's partnership with the Ohio Department of Mental Health & Addiction Services to implement Ohio's plan to end homelessness, *Blueprint to End Homelessness*; acts as OCD lead for policy development & implementation actions assigned to the agency within the plan.

Works with all nine Ohio Continua of Care (i.e., CoC) to help meet *Blueprint for Ending Homelessness* goals & federal benchmarks to end homelessness: Creates & evaluates data dashboard & reports to assist in monitoring progress of state & CoC achievement towards plan goals; collaborates with external stakeholders on the Ohio Human Service Data Warehouse project.

Responsible for OCD coordination with the Balance of State Continuum of Care (i.e., BoSCoC) & communication to OCD staff including, but not limited to: collaboration & representation on all BoSCoC workgroups, coordination of all grants with the BoSCoC, collaboration & representation on the Youth Homelessness Demonstration Project (i.e., YHDP), creation of Homeless Management Information Systems (i.e., HMIS)-generated reports, & continuous system performance improvement.

Assist Supportive Housing Manager with program implementation including program design, application review, monitoring, & program evaluation; maintains current knowledge of policies & initiatives of housing/homelessness offices in other statewide & federal agencies; reviews federal regulations that impact Supportive Housing programs & processes; advises supervisor of regulations' impact on OCD programs; makes policy recommendations to supervisor. Attends staff meetings, training sessions & conferences; performs other related duties as assigned. Demonstrates commitment to sound metrics, accountability & transparency while ensuring quality customer service.

1. Bachelor's degree in social science, public administration or related area. Master's degree preferred.
2. Extensive experience with program management, group facilitation & public policy research & development.
3. Experience in working with housing & homeless programs required.

5. Must possess valid driver's license & be able to travel to various sites around Ohio.
